Applications are invited from qualified and eligible **MALE CANDIDATES** for recruitment to the post of Assistant Lineman in the scale of Rs. 7,950 - 150 - 8,100 - 190 - 9,050 - 240 - 10,250 - 300 - 11,750 - 360 - 16,790, in Hubli Electricity Supply Company Limited.

1) **Composition of posts:**

A) For the candidates possessing a pass certificate of 18/24 months course in "Electrician" trade from Industrial Training Institutes (ITIs) recognized by the Government of Karnataka:

Note: Candidates selected as Assistant Lineman will be posted anywhere within the jurisdiction of the HESCOM and posting to the vacant posts will be done through counseling based on the merit.

2) **Requisite Qualification:**

Should have a pass certificate of 18/24 months course in "Electrician/Electronics/Electronic Mechanic" trade from Industrial Training Institutes (ITI) recognized by Government of Karnataka.

Note: Candidates possessing qualification in other disciplines/ branches other than what is specified above need not apply.

Other Qualifications:

- Should have knowledge of Kannada in reading and writing.
- Should have normal eye sight.
- Should have satisfactory physical fitness and shall qualify in the Endurance Test.

3) **Eligibility:**

The candidates who have obtained minimum percentage of marks as prescribed below in respective qualifying examinations only are eligible to apply for the posts.

Sl No	Category	Percentage
(a)	For applicants belonging to General Merit	60%
(b)	For applicants belonging to Category IIA, IIB, IIIA and IIIB	55%
(c)	For applicants belonging to SC/ST and Category I	Pass class

4) **Selection:**

i) Recruitment to the posts of ALM will be made by selection strictly on merit, based on the marks secured in the Qualifying Examination only provided he is qualified in 'Endurance Test', duly following reservation policy of Government of Karnataka. Candidates belonging to SC/ ST/ GM and other categories will be called for Endurance Test in the ratio of 1:5.

ii) Endurance test will be conducted in the following events;

No marks are allocated to the endurance test. However, in order to qualify for the selection, the candidate has to **compulsorily climb the Electric Pole(event No. d)** and get through in 2 events out of remaining 4 events (i.e. event No. a, b, c & e).

iii) Medical Examination will be conducted from the Competent Medical Officer during the Endurance Test and the candidate should have satisfactory physical fitness.

iv) The endurance test and verification of documents will be decentralized and will be conducted at the respective HESCOM's Circle Head Quarters. The details of HESCOM's Circle Head Quarters are as follow.,

v) Date, Time and Location of endurance test will be notified to the shortlisted candidates through website. Those candidates who give Mobile Number in their application forms will be intimated through SMS.

vi) The verification of the requisite certificates of the shortlisted candidates will be done at the time of the Endurance Test.

5) **Age:**

The candidates should have attained the age of 18 years as on the last date fixed for receipt of application and shall not be more than;

- 35 years in case of General Merit candidates.
- 38 years in case of Category IIA, IIB, IIIA and IIIB candidates.
- 40 years in case of SC/ ST and Category I candidates.

Note:

- The candidates who got trained for a period of three years as "Lineman/ Electrician" trade in KEB/ KPTCL Training Institutes, relaxation in the upper age limit will be given up to the period of training subject to a maximum of three years.

- b) For Ex-Military Personnel(Ex-MP) the upper age limit is relaxable by 3 years plus the No. of years of service rendered by them in the Armed forces of the Union of India not exceeding 45 years of age as on the last date prescribed for receiving the application.
- c) In case of in-service employees, the upper age limit is relaxable by the No. of years of continuous service rendered by them, subject to a maximum of 7 years.
- d) The candidates who worked or working on contract basis in KPTCL/ ESCOMs as Gangman/ Bill boys/ Probationary Mazdoor/ Temporary Sweepers/ Sanitary workers and Temporary Meter Readers the upper age limit is relaxable by number of years of service rendered by them subject to a maximum of 10 years. The Candidate claiming age relaxation on the above basis has to produce certificate from the concerned KPTCL/ ESCOMs authorities.

6) **Application Fee:**

- 1) Rs. 400/- (Rupees Four Hundred only) in respect of candidates belonging to General Candidate and Category I, IIA, IIB, IIIA, IIIB.
- 2) Rs. 200/- (Rupees Two Hundred only) in respect of candidates belonging to SC/ST Category.

7) **Submission of Application:**

- a) Applications should be submitted strictly through "ONLINE" by logging on to HESCOM website at <http://www.hescom.co.in/>. Applications will not be accepted by any other mode.
- b) The Applications shall be submitted through online from 12 - December - 2011 to 11 - January - 2012 till 17.00 hrs.
- c) Candidates are allowed to apply only once and application once submitted cannot be altered under any circumstances.
- d) After applying, the candidates should obtain the Bank Challan generated online and pay the requisite application fee along with applicable bank charges in any of the branches of State Bank of India.
- e) In case, the candidates fail to pay the fees after submitting the application, their applications will not be considered.

Special Note:

- Candidate who pays the requisite application fee, by obtaining 'Bank Challan', during the Banking hours between 12 - December - 2011 to 11 - January - 2012 after submitting the application through 'On-Line'; only such applications will be considered for recruitment.
 - The application fee paid before or after the NOTIFIED DATE, such candidate's application will not be considered for recruitment purpose and the amount paid will not be adjusted or refunded under any circumstances.
- f) Fees paid once shall not be refunded under any circumstances or adjusted towards future recruitments.
 - g) After submitting the application ONLINE the candidates should obtain the printouts of acknowledgement and Bank Challan and same should be produced at the time of 'Endurance Test'.
 - h) Candidates should submit the applications well in advance without waiting for the last date prescribed for submission.

8) **General Instructions:**

- a) No person who has been convicted of an offence involving moral turpitude or who has been temporarily debarred or disqualified by the Union or any State Public Service Commission from appearing for examination or selections conducted by it shall be appointed unless the Company after review of all the circumstances considers him suitable for such appointment.
- b) Candidates who obtain appointment by furnishing false information in the application are liable to be terminated.
- c) Postal address furnished in the application is final and no correspondence for change of address at a later date will be entertained.
- d) Candidates who have appeared for the qualifying examination but whose results are not declared before the last date fixed for receiving applications, need not apply.
- e) Before filling up the online application forms, the eligible candidates shall go through instructions made available in the website.
- f) Candidates are expected to know the criteria for claiming reservation under SC, ST, Categories I, IIA, IIB, IIIA, IIIB as well as norms for horizontal reservation under each quota prevailing in Government of Karnataka as on the last date prescribed for submission of application.
- g) The decision of HESCOM in matters relating to eligibility of candidates will be final and binding.

- h) Canvassing in any form for appointment will be a disqualification.
- i) Original documents/ Testimonials/ Certificates/ Records etc., shall be produced for verification with attested copy, only when called for.
- j) Only Indian citizens are eligible to apply.
- k) The Company reserves the right to cancel the Employment Notification during any stage and without prejudice to issue fresh notification, if necessary.
- l) No correspondence or enquiries will be entertained from candidates about the status of recruitment process.
- m) Candidates applied under Category – I, IIA, IIB, IIIA, IIIB, Scheduled Caste and Scheduled Tribe their appointment Orders will be issued only after receipt of validity certificate [‘SINDHUTHVA PRAMANA PATRA’] from concerned competent authority irrespective of their selection[GM/ Category]
- n) All relevant information at various stages of recruitment will be made available on the HESCOM website <http://www.hescom.co.in/>.

9) **Instructions to the Candidates for the post of Assistant Lineman:**

Along with this Notification “Instruction to the Candidates for the post of Assistant Lineman” is issued; the applicant should go through it.

10) **Horizontal Reservation:**

- i) **Rural Candidate:** Candidates claiming reservation under Rural quota should have studied from 1st to 10th Std in Rural areas. The Rural Study certificate should be produced in the format in the prescribed in GO No. DPAR 96 SRR 2005 dated 10.08.2005, duly attested by the Head Master of the School and ‘Countersigned’ by the concerned BEO.
- ii) **Ex-Military personnel:** Should possess discharge certificate for having served in Military/ Defense/ Armed forces.
- iii) **Kannada Medium Candidate:** Should have studied in Kannada Medium from 1st to 10th Std. duly attested by the Head Master of the School and ‘Countersigned’ by the concerned BEO.
- iv) **Project Displaced Candidate:** The candidates should possess certificate issued by the concerned authority for having lost their agricultural land/ residence for projects.
- v) **Physically Handicapped Candidate:** Should possess a medical certificate issued by the Competent Medical Authority to show physical defect or deformity to an extent of minimum 40% which causes in interference with the normal functioning of bones, muscles and joints.
